- i. support the ongoing work of ASBE in Atlantic Canada
- ii. identify as a church/organization that supports ASBE and also promotes the equal partnership of men and women, and of all racial and ethnic groups, in the home, the church, and the community.
- iii. be provided with the ASBE logo, to identify your church/organization as a partner.
- iv. be identified on the ASBE website as a church/organizational partner supporting the mission of ASBE.
- v. receive one free individual, 1-year membership for ASBE, usable by a leader/member of your church/organization. <https://www.biblicalequality.org/membership>
- vi. send this (identified in v.) representative to participate in the ASBE annual general meeting.
- vii. receive regular updates from ASBE, including our annual report.
- viii. be prioritized in receiving resourcing from ASBE – such as: ASBE booklets/articles, booking ASBE for a workshop, booking ASBE to share on a Sunday morning, or inviting ASBE in other ways to assist in your ministry and mission.

To become an official church/organizational partner with ASBE a church/organization must:

- i. Be a church/organization, of any denomination, located within Atlantic Canada.
- ii. Have the leadership agree with the following three ASBE documents:

 - b. [Statement of Faith](#) and
 - c. [Statement on “Men, Women and Biblical Equality”](#)
- iii. Fill out the church/organizational partnership form, which must include a signature from the Solo/Senior/Lead Pastor or Executive Director and the Chair of the Board of your church/organization (e.g. Deacons/Board/Elders/Session)
- iv. Provide minimum annual support of \$100* (more is welcomed) from your church/organization to ASBE. Our recommendation is churches/organizations consider making ASBE part of their annual budget.
